All features of the current roof will be retained including the leadwork, coping stone gable details and the small lead clad dormer window to the front elevation. Whist the building is scaffolded, the windows will all be repaired where necessary, and re-painted in white. The current external paint coating has broken down and is peeling badly. This will be removed where necessary. The cement-based render beneath it will be repaired and the final finish with be either the bare render if condition and paint removal make this possible, or a breathable high-quality paint finish closely matching the brown/grey colour of the render. Gutters and drainage pipes will be repaired, re-painted and replaced on a like-for-like basis where necessary.
