



Mold's Virtual Santa Dash Terms and Conditions

Registration

Participants must submit an official registration form for all those participating in Mold's virtual Santa Dash, including those under 12 years of age who are taking part.

All ages are welcome to take part in the Mold Santa Dash, under 16s must be accompanied by an adult.

Participants over 12 years of age are required to pay a minimum donation of £5 per person and in return will receive a Santa Suit which is adult / one size only.

Children under 12 years can entry free of charge, however you may wish to purchase an adult suit for them to wear the Santa jacket, hat and beard only for a minimum donation of £5 per suit.

All participants will receive a medal, race number and certificate.

Collection / Delivery of Santa suits and medals.

Participants can collect their suits from Mold Town Hall, Earl Road, Mold CH7 1AB on Wednesday's and Saturday's between 10am – 2pm. Alternatively entrants living in Mold or within 2 mile radius can request delivery, which can be arranged non contact.

Safety

Participants taking part in Mold Town Council virtual events do so entirely at their own risk and are 100% responsible for selecting a safe route to walk or run.

The Virtual Mold Santa Dash involves a level of sustained physical activity. Participants make the decision to take part and must be satisfied that this activity is suitable for them as individuals. Mold Town Council cannot be held accountable for aggravation to illness or injury sustained due to participation in this activity.

We strongly advise that all participants wear appropriate footwear and clothing to ensure their safe and enjoyable participation.
